

SDAD Board meeting

Held at Spearfish Public Library, Saturday, September 9th, 2017

The SDAD Board meeting came to order at 1:30 PM MDT with the following Board members present:

Agenda:

Scott Miller (Sonny Rasmussen) moved to accept the agenda as read. Carried.

Public Input:

Kevin Barber: Expressed a concern about passive membership, and wanted to host a membership forum / town hall meeting later this month

Tim Nold: Wondered when the SDAD website would be updated and when the new bylaws would be posted

New Business:

1. Teresa Nold (Lance Sigdestad) moved that SDAD host the Christmas dinner statewide. Carried.
2. Teresa Nold (Callista Powell) moved that all of SDAD's communications (Facebook page, newsletter, flyers, etc. be available to non-members as well as members). Carried.
3. Sonny Rasmussen (Scott Miller) moved that the SDAD budget be adjusted to account for the increase in the auditor / 990N filing fee (from \$600 to \$1300). Carried.
4. Lance Sigdestad (Sonny Rasmussen) moved to confirm Jeff Panek as the chair of the Emergency Preparedness Committee. Carried.
5. Teresa Nold (Callista Powell) moved to request a line item be added to the budget in the amount of \$10,000 for interpreting services required during LEAD-K taskforce meetings and meeting with legislators. Carried and referred to the Finance Committee.
6. Sonny Rasmussen (Teresa Nold) moved that the next SDAD Conference be held on June 21 and 22, 2019 at the Holiday Inn and Convention Center in Spearfish. Carried.
7. Lance Sigdestad (Tamra Trujillo) moved to give \$500 to the SDSA Carnival as a sponsorship. Carried.
8. Mark Koterwski (Teresa Nold) moved to allow non-members to serve on the LEAD-K taskforce. Carried.
9. Callista Powell (Lance Sigdestad) moved to allow per diem meal reimbursement for board members that do not have to travel overnight to SDAD Board meetings. Carried with two-thirds majority.
10. Sonny Rasmussen (Scott Miller) moved that SDAD host the Super Bowl party at the Phoenix Bar in Harrisburg on February 4, 2018. Carried.
11. Teresa Nold (Lance Sigdestad) moved to donate \$250 to NAD. Carried.
12. Lance Sigdestad (Sonny Rasmussen) moved to recognize the Dakota Athletic Association of the Deaf as an affiliate. Carried.
13. Mark Koterwski (Callista Powell) moved to set up a committee to order shirts for the LEAD-K group members and Board members. Carried.
14. Callista Powell (Mark Koterwski) moved to confirm David Dahle as the SDAD Technology committee chair. David Dahle (Sonny Rasmussen) amended to approve all the President's recommendations for committee chairs with the exception of the auditors. Amendment and main motion carried.

15. Mark Koterwski (Sonny Rasmussen) moved that Jeff Panek, Teresa Nold, and Scott Miller be the official SDAD representatives on the SDSD land taskforce. Carried.
16. Callista Powell (Lance Sigdestad) moved that SDAD redesign the website. Sonny Rasmussen (Mark Koterwski) amended to refer this task to the Technology committee. Amendment and main motion carried.
17. Teresa Nold (Scott Miller) moved to give \$500 to Tamra Trujillo for reimbursement of outstanding expenses for the Deaf Grassroots Movement and as an allowance for future expenses. Tamra Trujillo abstained from discussion and vote. Carried.

Scott Miller also took a moment to thank Tamra Trujillo for her service with the South Dakota branch of the Deaf Grassroots Movement.

18. David Dahle (Sonny Rasmussen) moved that the Governance Committee develop guidelines for the post-conference transitional Board meeting, which was added in a recent bylaw change. Callista Powell (Lance Sigdestad) amended that the meeting be held within a month of the conference. Amendment and main motion carried.
19. Sonny Rasmussen (Mark Koterwski) moved that the next SDAD Board meeting be held on the same weekend in December as the SDAD Christmas Dinner (the Saturday before). Carried.
20. David Dahle (Teresa Nold) moved to close New Business. Carried.
